Help the children to obtain the special findings of fact needed so they can then apply to the USCIS for SIJS.

Roger Williams Law School Pro Bono Collaborative Expungement Clinic: Participate in clinics and represent persons in need of expungements, referred through various community organizations.

Veterans Project: Help veterans who have claims for health care and disability rights and benefits against the armed services and VA. You can also help veterans to apply for "Combat Related Special Compensation" (CRSC), which entails completing an application form and submitting evidence proving that the veteran's disabilities satisfy the statutory definition of "combat related." We have a training session on video, which you can watch from your desk.

The Massachusetts Legal Clinic for the Homeless (MLCH): Is a collaborative of eight of the state's largest law firms, including Nixon Peabody, that provide on-site legal services to the residents of several homeless shelters. You will help homeless individuals to deal with the administrative consequences of their prior cases. Most of these individuals are in a program at the shelter that assists them with their transition back into the workforce.

Asylum Project: In a program run by PAIR and BC Law School, we are helping refugees who have been persecuted in their home countries to win asylum in the U.S. You do not need to be a litigator.

American Cancer Society: Draft wills, powers of attorney, and other estate documents for low-income cancer patients.

Real Estate Bar Association Pro Bono Program: This is a subprime loan assistance initiative. Our lawyers will provide pro bono legal assistance to low- and moderate-income borrowers facing foreclosure or other legal action as a result of the subprime loan crisis. This is a very good program for litigators and real estate attorneys.

BBA Trusts and Estates Section Pro Bono Project: This is an advice and intake line for trusts and estates-related legal problems. This is a very good program for private client attorneys.

The Volunteer Income Tax Assistance (VITA) Program: Offers free income tax preparation to low-income families. Training is provided.

Microfinance: Play a role in the securing of microloans for poor individuals—mostly women—in the developing world who have little or no access to credit. Our clients require sophisticated securities and investment-related work, which offers excellent pro bono opportunities for attorneys with securities and public finance experience.

Green Pro Bono: Provide pro bono legal assistance to organizations that are involved in environmental or sustainability matters.

Reducing Gun Violence: We have a firm-wide initiative based in Rochester and SF aimed at reducing gun violence. We work with the Law Center to Prevent Gun Violence and the NYSBA Task Force on Gun Violence to conduct research and/or draft amicus briefs in connection with constitutional issues involving challenges to gun laws. Lawyers in any office can support this work.

FOR ROCHESTER ATTORNEYS:

Veterans Project: In partnership with LawNY, we will assist veterans with their legal needs by hosting "Military Mondays." Twice a month, 2 lawyers spend 2 hours meeting with 2 veterans on a pro bono basis. The "clinics" would happen at a Canandaigua Starbucks (this initiative is to help Vets in the Finger Lakes area). Our liaison from LawNY would be in attendance at the clinics to provide support and answer our questions.

Transgender Name Changes: Help transgender individuals to secure name changes. For many transgender people, a legal name change is the first step toward conforming their legal identities to the way they identify and live their lives. Each project is relatively discrete and predictable, and involves no litigation.

Special Education: Help low-income families obtain needed special education services including helping parents advocate for Individual Education Plans for their children. No litigation involved.

U Visa Applications: Help low-income women immigrants obtain U Visas, offered to victims of certain crimes, like domestic violence, who cooperate in the investigation or prosecution of their attacker. A U Visa allows an immigrant (and family) to work and live lawfully in the United States, and creates a pathway to lawful permanent resident status. No litigation is involved; you help the client complete an application with supporting affidavits. A typical case takes about 20 hours to complete.

Monroe County Arts & Cultural Council: Help individual artists and arts-related organizations with non-profit formation and intellectual property issues, among other things.

Micro-Entrepreneurship Program: NYS has developed a legal referral system, called Business Mentor NY, which is a web-based initiative that connects low-income small businesses and entrepreneurs around New York State, particularly in rural areas, with attorneys and other professionals. We help small businesses and entrepreneurs in a wide variety of non-litigation matters, including advising on corporate, tax, finance, intellectual property, real estate, employment, and other legal matters. This is a great project for business, employment, real estate, and IP lawyers.

Asylum Project: We receive referrals from Legal Aid Society of Rochester of individuals fleeing persecution in their home countries. You can take on a case before the Asylum Office (which is an interview only) or have a hearing before an immigration judge. You don't need to be a litigator.

Reducing Gun Violence: We have a firm-wide initiative based in Rochester and SF aimed at reducing gun violence. We work with the Law Center to Prevent Gun Violence and the NYSBA Task Force on Gun Violence to conduct research and/or draft amicus briefs in connection with constitutional issues involving challenges to gun laws.

Rochester Office Pro Bono Housing Initiative: Attorney for the Morning program—go to housing court on behalf of low-income tenants one morning a month. You do not need to be a litigator. Less experienced lawyers learn by observing experienced lawyers and from a simple one page "cheat sheet" covering the issues. You participate when you're ready.

Rochester Office Pro Bono Housing Initiative: Advise Habitat for Humanity on lot acquisitions.

American Cancer Society: Draft wills, powers of attorney, and other estate documents for low-income cancer patients.

Microfinance: Play a role in the securing of microloans for poor individuals—mostly women—in the developing world who have little or no access to credit. Our clients require sophisticated securities and investment-related work, which offers excellent pro bono opportunities for attorneys with securities and public finance experience.

Green Pro Bono: Provide pro bono legal assistance to organizations that are involved in environmental or sustainability matters.

Divorce and Custody: You will work with the Volunteer Legal Services Project with numerous legal issues for its clients. VLSP handles divorce cases for people who have been victims of recent serious physical abuse or, on a more limited basis, who have children and physical residence in dispute. VLSP handles cases involving arrears in child support or maintenance. You will provide

advice to individuals on custody and related issues and helps people complete Family Court petitions for custody, visitation, or guardianship. VLSP also runs a "do-it-yourself" pro se divorce class for people seeking a divorce who have no issues in dispute.

Child support: VLSP represents individuals seeking to establish child support or seeking to obtain, enforce, modify, or defend a child support order.

Unemployment Insurance and SSI: VLSP represents claimants whose claims for unemployment insurance benefits have been turned down by the Department of Labor or challenged by the employer. VLSP handles these cases at the hearing level only. VLSP also accepts SSI referrals from Empire Justice Center.

VLSP's Debt Collection Advice Clinic: Volunteer attorneys meet privately with clients dealing with problems such as garnishment, collection efforts, repossession, etc. Clients receive case analysis and self-help advice, and sometimes receive further help (for example, bankruptcy or repossession defense).

Employment: VLSP assists when legal problems prevent a person from getting or keeping employment. Examples include problems with LPN licenses, foster care licenses, criminal records, child abuse records, and loss of drivers' licenses because of unpaid judgment or child support.

Consumer Problems: VLSP assists with problems like "lemon" cars, liens on bank accounts, unfair contracts, insurance coverage, student loans, rent-to-own contracts, etc.

Standby Guardianships: For parents with HIV/AIDS or other serious illnesses, VLSP helps with planning for the future care of children. VLSP also helps family members and others who are taking care of children to obtain guardianship.

Tax: VLSP handles almost any type of dispute with the IRS including, but not limited to, issues with earned income tax credit, dependency exemptions, head of household filing status, pension income, independent contractors, and other tax issues. VLSP also helps with examinations or audits, collections, appeals, and injured spouse tax relief.

Immigration: VLSP handles basic family-based adjustment status cases, permanent residency applications and some naturalization cases for low-income individuals.

FOR SAN FRANCISCO ATTORNEYS:

Lawyers' Committee for Civil Rights (LCCR):

<u>Asylum Project</u> – we help refugees who have been persecuted in their home countries to win asylum in the U.S. We represent clients at all levels of the process, from the SF Asylum Office (offensive applications) to SF Immigration Court (defensive applications) to appeals before the Board of Immigration Appeals or the Ninth Circuit.

<u>Special Education</u> – we help low-income families deal with a variety of educational issues, including negotiating an Individualized Education Program for their children.

Center for Gender and Refugee Studies (CGRS):

CGRS works to protect human rights for refugees, women, and LGBT. You can get involved with their asylum projects. There may also be opportunities to work on immigration policy reform.

Justice & Diversity Center of the Bar Association of San Francisco (BASF):

BASF's Justice & Diversity Center's Community Organization Representation Project (CORP) - the CORP program helps local community groups that are in need of transactional services. The primary areas of law that are involved are labor and employment, tax, corporate formation and real estate.

<u>Housing Negotiation Project (HNP)</u> - we represent tenants in settlement conferences at the Court House. This involves a limited time commitment, typically four hours or less.

<u>Litigation Opportunities</u> – training and opportunities to take on litigation matters involving family law, landlord/tenant, consumer law, torts and wills, and other disputes.

Swords to Ploughshares Veterans' Project:

We will be helping service members and veterans seeking military or VA health care and disability benefits to which they're entitled. Separately, we also help veterans apply for Combat Related Special Compensation (CRSC) through a NVLSP program.

Bay Area IMPACT project's Rural Justice Collaborative (RJC) clinics:

One Justice and other Bay Area legal services providers launched the RJC clinics to engage law firm attorneys in expanding access to legal assistance in Gilroy, Half Moon Bay, and Napa County, all regions with very limited if any legal aid resources in place. RJC organizes monthly free legal clinics in each location, focusing initially on immigration and housing issues.

Law Center to Prevent Gun Violence (LCPGV):

LCPGV was formed in the wake of the 1993 mass shootings at the law firm of Pettit & Martin in San Francisco. Several NP attorneys knew some of the individuals killed. Our lawyers in different offices do significant pro bono work for this client with the goal of reducing gun violence, primarily by authoring amicus briefs in litigation across the country.

AIDS Legal Referral Panel (ALRP):

ALRP's mission is to help people with HIV/AIDS maintain or improve their health by resolving their legal issues. ALRP screens and refers all types of civil matters, the most common being bankruptcy/credit, confidentiality, employment, family law, housing, immigration, or insurance/benefits cases.

Legal Services for Children (LSC):

LSC was founded in 1975 as one of the first non-profit law firms in the country to provide free legal representation and social work services to children and youth. LSC's mission is to ensure that all children and youth in SF Bay Area can be raised in a safe environment with equal access to a meaningful education and the services and supports they need to become healthy and productive young adults. LSC pioneered a unique interdisciplinary approach to legal services, employing teams of attorneys and social workers to comprehensively meet the needs of our clients. LSC offers cases that include legal guardianship, dependency, school discipline, immigration, emancipation, and restraining order proceedings.

Advokids:

Advokids' staff attorneys and pro bono attorneys provide assistance in preparing appellate briefs and amicus briefs in selected cases where there is a question of law that is critical to protecting the health, safety or well-being of foster children in California.

East Bay/ Silicon Valley Habitat for Humanity:

We work on legal issues in employment, real estate, bankruptcy, and finance.

East Bay Community Law Center (EBCLC):

Since its founding in 1988 by law students at UC Berkeley's Boalt Hall School of Law, EBCLC has become the largest provider of free legal services in the East Bay and a nationally-recognized poverty law clinic. EBCLC provides desperately-needed legal services to the low-income community in the areas of housing, welfare, HIV & health, homelessness and economic development.

Legal Aid Society of San Mateo (LASSM) and Legal Advocates for Children & Youth (LACY):

<u>Guardianships</u> - we represent minors or caretakers in petitioning the Probate Court for legal guardianship. Our lawyers partner with in house counsel at Intel Corp.

<u>Domestic Violence projects</u> - we provide limited scope representation at permanent restraining order hearings to low-income victims of domestic violence so that they can remain out of abusive relationships and establish safe and stable lives. Issues may include child custody, visitation and support.

California Lawyers for the Arts:

<u>California Inventors Assistance Program</u>, which is a USPTO initiative that matches attorneys with *pro se* low income applicants needing patent prosecution legal services.

Assist artists or art-based organizations relating to copyright law, contract drafting, review and negotiation, nonprofit organization issues, landlord/tenant, organizational tax (not individual tax), employee/independent contractor and mediation and arbitration.

Federal Pro Bono Project:

Cases in the Northern District are referred for appointment of counsel by the Court. Opportunities to represent both pro per plaintiffs and pro se defendants. Cases range greatly; often they involve federal civil rights violations, such as police battery and wrongful arrest under § 1983.

Ninth Circuit Court of Appeals Pro Bono Project:

The Ninth Circuit Court of Appeals established its pro bono program in 1993 to provide pro bono counsel to pro se parties with meritorious or complex appeals, to provide a valuable learning experience to young attorneys and law students, and to assist the court in processing pro se civil appeals more equitably and efficiently.

Accountability Counsel:

Accountability Counsel defends the environmental and human rights of marginalized communities around the world. As lawyers for people harmed by internationally-financed projects, they focus on innovative ways to provide access to justice.

Election Protection:

As we get closer to Election Day, we will have the opportunity in several of our offices to help protect the right to vote by answering questions and serving as poll watchers, while working with a non-partisan organization such as the national Lawyers Committee for Civil Rights. This will involve a discrete, time-limited commitment, and no litigation.

Patents for Humanity:

Develop materials to publicize the Patents for Humanity program and Nixon's Foundation in support of the program, find speaking opportunities at professional meeting, and look for ways to educate companies and clients about the Program.

Law Foundation of Silicon Valley:

<u>LACY</u> guardianship cases. LACY's Guardianship Project provides representation to children and families in guardianship matters. When children in our community are not able to live with a parent because of death, incarceration, abuse or neglect, pro bono attorneys can help a child achieve safety and stability by representing the youth or prospective guardian in a guardianship proceeding.

<u>Nonprofit Legal Assistance project</u>. Assistant nonprofit organizations that serve low-income individuals in Santa Clara County to enable them to provide fundamental services to underserved populations with their legal needs.

<u>Volunteer Eviction Assistance/Rural Justice Collaboratives.</u> Many residents in Santa Clara County face serious housing problems. The Law Foundation, in collaboration with several other legal services organizations, hosts a weekly Friday morning clinic in San Jose as well as a one-time-per-

month clinic in South County. At both clinics, pro bono volunteers analyze individual housing cases and provide clients with advice, counsel and brief legal services in housing matters.

<u>Impact Litigation cases</u>. Co-counsel cases representing victims of housing discrimination and illegal mortgage lending practices or civil rights; fair, habitable, and affordable housing; consumer protection; disability access; education and other youth rights; and rights of individuals in institutions.

FOR SILICON VALLEY ATTORNEYS:

Patents: California Lawyers for the Arts refers patent pro bono clients to us. Patents for Humanity: Develop materials to publicize the Patents for Humanity program and Nixon Peabody's Foundation in support of the program, find speaking opportunities at professional meetings, and look for ways to educate companies and clients about the Patents for Humanity program.

Guardianships: Represent minors or caretakers in petitioning the Probate Court for legal guardianship in a matter referred by Legal Services for Children, LACY, or San Mateo Legal Aid, as part of our pro bono partnership with Intel Corp. You do not need to be a litigator to handle this administrative proceeding.

Micro-Entrepreneurship Program: As part of our pro bono partnership with Intel Corp., provide low-income individuals in underserved and economically distressed communities in the SF area with vital business legal services as they start or grow their own business. This is a great project for business, TIP, employment, and real estate lawyers.

Asylum Project: In a program run by the Lawyers Committee for Civil Rights, we are helping refugees who have been persecuted in their home countries to win asylum in the U.S. You do not need to be a litigator.

Bay Area Legal Aid U Visa Project: Help low-income women immigrants obtain U Visas, offered to victims of certain crimes, like domestic violence, who cooperate in the investigation or prosecution of their attacker. A U Visa allows an immigrant (and family) to work and live lawfully in the United States, and creates a pathway to lawful permanent resident status. No litigation

involved; you help the client complete an application with supporting affidavits. Typically takes 20 hours to complete.

Women's Initiative: Advise on employment, corporate, and franchise issues for organization devoted to assisting disadvantaged women develop and grow their own businesses.

These include handling appeals with the Veterans Consortium Pro Bono Project, handling CRSC or PDBR applications with NVLSP Lawyers Serving Warriors, joining the National Housing Conference's vets in housing working group, partnering with the Puller Clinic for referrals involving first level intake for local vets and establishing clinic programs at DC law school(s). Lawyers Committee for Civil Rights: Provides referrals of matters involving civil rights, voting rights, affordable housing, and community development.

DC Bar Affordable Housing Program: Provides referrals on community development matters.
